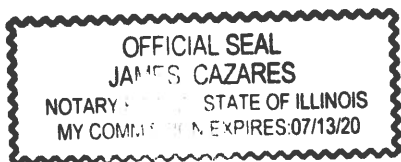


**AGREEMENT TO
