VI. RECOGNITIONS AND PRESENTATIONS

A. 100th Birthday Proclamation - James P. Ostler, Sr

President Hayes read the proclamation for Mr. Ostler saying he recently received the French Legion of Honor medal for his heroics in World War II. Mr. Ostler is a 65 year resident of the Village.

B. COVID19 Update

President Hayes said Illinois is close to the peak of the bell curve of the virus. The State government is looking at ways to reopen. It will be a phased and gradual process. President Hayes urged residents to follow the guidelines and stay the course. Mask wearing in indoor places is mandatory beginning May 1st. He said the Village does not need to issue a separate order as the State order covers the Village. He encouraged residents to do all they can to support local businesses.

Mr. Recklaus said the Village is still in operation. While Village Hall is closed to walk in visits, every Village employee is still working. Schedules, assignments, and working locations have been modified to protect employees and the public, but Village staff is still here to serve the public. While residents are encouraged to do business with staff over the phone or electronically, they can still make an appointment to do business at Village Hall.

Police Calls for service have changed, with nuisance calls regarding social distancing issues going up by 369%. Traffic, crime and domestic calls are down. The Building Department is still conducting inspections and reviewing applications. Permits are still being issued.

The Village's Emergency Assistance Fund which provides emergency help to residents in need has had a large increase in applications. This means-tested program focuses on short term assistance for people who are having paying for basic needs such as rent. If residents would like to donate to the program they may do so at Arlingtoncares.org.

The Village is working on a relief package for businesses in addition to the tax deferrals that have already been put into effect and will be discussing them at the next Board meeting in May. The focus is on ensuring what is developed reflects needs which have been unmet by State and Federal packages. Staff is also looking into ways the current regulations can be more flexible to help businesses.

Lastly, is the fate of the summer festivals. With the announcement of the extension of the Stay at Home Order, staff is examining the possible cancellations of some of the Village's planned summer events in June. Organizers have already cancelled the Memorial Day Parade and Public Ceremony and the Salute Run. There will be additional announcements on the status of June events made in May.

Resident Melissa Cayer emailed two questions to the Board:

1. Are the Pension Fund's Fund Manager performances considered as a variable by the actuaries? Mr. Kuehne said yes, the manager's performance is reflected in dividends and in the year end market value. In 2019 the Fire Pension Fund was up 15% and the Police Pension Fund was up 20%.
2. If several actuaries were asked, would they come up with the same formulas? Mr. Kuehne said the Pension Funds assume the method and formulas used by the actuaries. Therefore, all assumptions and methods are exactly the same and should have the same results.
