Requirements for Enclosed Tents for Restaurants

Tents are considered to be enclosed if they have walls (including temporary or permanent) on three or more sides. Following are the requirements for enclosed tents.

- Application for a Tent must be submitted to the Village Department of Building & Life Safety. This application can be found on the Village's website: <u>building@vah.com</u> Following these Requirements, is a list (Supplemental Regulations for Enclosed Tents) of additional information/documentation that must be submitted along with the Tent Application.
- 2. Heating equipment, propane heaters, unvented heaters are not permitted inside the walls of any tent.
- 3. No heating devices with any type of open flame or fuel source, i.e. propane, are allowed inside or located within 20 feet of the tent.
- 4. Cooking and heating equipment shall not be located within 10 feet of exits or combustible materials.
- 5. The storage, handling and use of LP-gas and LP-gas equipment shall be located outside the tent. Safety release valves shall be pointed away from the tent.
- 6. Generators and other internal combustion power sources shall be separated from tents by a minimum of 20 feet and shall be isolated from contact with the public by fencing, enclosure or other approved means.
- 7. At least one exit and not less than the number of exits required based on the occupant load shall be provided.
- 8. The combined width of all exit doors along with the proposed seating capacity, must comply with Village Building and Fire Codes.
- 9. The width of aisles without fixed seating shall have a minimum width not less than 44 inches. However, there must be a minimum six-foot separation between tables.
- 10. Access for emergency vehicles shall be provided and maintained at all times.
- 11. Exits shall be spaced at approximately equal intervals around the perimeter of the tent and shall be located such that all points are 100 feet or less from another exit.
- 12. If a tent seats 50 or more, internally illuminated Exit signs must be provided. Electricity for the signs must be supplied by two separate electrical circuits, one of which shall be separate for all other circuits.
- 13. The means of egress shall be illuminated with light having an intensity of not less than 1 foot-candle at floor level while the structure is occupied. Fixtures required for means of egress illumination shall be supplied from a separate circuit or source of power.
- 14. Portable fire extinguishers shall be provided.

SUPPLEMENTAL REGULATIONS FOR ENCLOSED TENTS

Along with the Tent Application the following information must be submitted.

- 1. Site Plan providing the following information.
 - a. Location of size of tent(s).
 - b. Identify which sides of the tent with walls, including both fabric and permanent.
 - c. Location and size of tables, including associated seating, as well as dimensions between tables.
 - d. Location and size (in inches) aisles.
 - e. Distance of tent from adjacent building.
 - f. Identify location and size of existing exits in the restaurant building.
 - g. A lighting detail showing how tent will be lit, including electric source for lights. Detail should also include Exit signage.
 - h. Location of heating device(s).
- 2. Detail of how tent will be heated including:
 - a. Type of heating unit to be used (provide manufacture's cut sheet).
 - b. Identify where fuel will be stored.
 - c. Location, size and ducts.

Submittal Process and Checklist

APPLYING FOR PERMITS:

Submit all materials via email to: Building@vah.com. You will receive an email notification within 24 hours that your email was received. If you do not receive an email response, contact us at 847-368-5560.

APPLICATIONS AND FORMS REQUIRED:

The applications and forms that you need to submit are listed on the next page of this checklist. Please be careful to fill these out <u>completely</u>. Incomplete, illegible or lack of information, can delay your permit from being processed.

* If you are the homeowner doing the work yourself, please fill out and submit the <u>Homeowner as General Contractor</u> form with your applications. This form is found at www.vah.com.

CONTRACTOR LICENSE:

The Village of Arlington Heights Contractor license number must be listed on the permit applications. Their license numbers can be looked up on our web-site at:

REVIEW TIME FRAMES:

Please allow 10 working days for plan review. Each revision or re-submittal can take an additional 10 working days.

PROCESSING NOTIFICATIONS:

When reviews are completed, if approved, you will receive a pick-up notification packet by email. If a correction or revision is required, you will receive Plan Review Comments. When submitting revisions/corrections, please provide detailed written response of the changes.

FEES:

Fees are not pre-set based on project type. The pick-up notification packet will show the detailed permit cost for the project.

Once payment is received, your plans and permit placard will be emailed to the <u>applicant</u> within 24 hours. Please print the plans and permit placard and have available at the site for inspection.

INSPECTIONS:

Inspections are required; please call 847-368-5560 at least one day in advance to schedule your inspection. The **permit number** and **project address** are required when scheduling.

Applications, Forms and Other Materials to be supplied for the following type of project:

Tent

Tent permits are only needed for tents with one or more lowered side panel(s) that are over 400 sq. ft. in area, or up to 700 sq. ft. with no sides.

Supply those items marked below to ensure your submittal is complete. Fill out all forms clearly and accurately.

- Fire Life Safety Permit Application
- Electrical Permit Application (if applicable) (include copy of Electrical License)

Forms Required: (as applicable)

• Tent Permit Information Sheet

Materials to be Submitted (one set of each of the indicated items):

- <u>Fire Safety Tent Permit Application</u> found at the bottom of the <u>Fire Safety Tent Permit Information</u> <u>Sheet</u>
- Plat of Survey showing the proposed size(s) and location(s) of the tent(s), generator(s) (*if applicable*), distance to structures and emergency exists.
- Contractor's Proposal explaining the scope of work to be performed.
- Project specific materials:
 - 1. Tent information and Certificate of Treatment for Flame Retardancy
 - 2. Supply the wattage of the generator to be used to determined if a permit is required

IMPORTANT PLEASE READ BEFORE FILLING OUT APPLICATION

A permit must be obtained for all installations or alterations of electric equipment.

A permit must be obtained before the work is started.

Application for the permit must give the location by street and number. Locations on corners will not be accepted. The street number must be correct.

Application must be filled out in its entirety and signed by the Electrician or an Authorized agent.

Electrician must provide copy of registration with each submittal. <u>Both Application and license /</u> registration must be received together or neither will be accepted.

The inspection fee must be paid before a permit is issued. As this fee is based on the apparatus installed, a correct statement of such apparatus must appear on the application.

The permit issued on this application will authorize only work here applied for. If other work is done, it must be covered by additional permits or as an addendum to the existing permit.

Contractor shall not make connection to existing wiring where same is defective. In all cases the contractor installing the apparatus, in addition to existing load, shall be held responsible for any overload of service, branch mains or circuits.

No current shall be used on the apparatus installed under authority of a permit without approval of Building & Life Safety Department.

When this installation is ready to be energized, an inspection must be approved by the Electrical Inspector.

Fire Safety Tent Permit Information Sheet

Please review the items below carefully and if you understand each item and agree to comply with each as stated please go to the bottom of this document and sign your name where it states that you understand and agree to comply. Tents less than 700 sq. ft. open on all sides do not require a permit.

If any of items 1, 2 or 3 below apply to your situation additional information is required for review before a permit can be approved. Please provide that information with this signed acknowledgement form.

- If the occupant load of any tent will be 50 or more, or the sides of the tent(s) are lowered, a detailed site and floor plan is required. The plan should show details for the means of egress (exiting) to include seating capacity, arrangement of the seating and location, exit & emergency lighting, and type of heating and electrical equipment if proposed.
- 2. If the sides of the tent(s) is/are **NOT OPEN** there shall be at least one exit and not less than the number of exits required based on the occupant load. An occupant load of 200-499 shall have at least 3 exits which shall be at least 72" wide each.
- **3.** The width of aisles without fixed seating in public areas shall be smooth-surfaced, unobstructed with a minimum width of not less than 44 inches.
- Access for emergency vehicles shall be provided and maintained at all times.
- > A copy of certificate showing flame retardant treatment is required.
- Tents shall be adequately roped, braced and anchored to withstand the elements of weather and prevent against collapsing.
- Exits shall be spaced at approximately equal intervals around the perimeter of the tent and shall be located such that all points are 100 feet or less from another exit.
- > Aisles shall be maintained clear at all times during occupancy.
- Exits shall be clearly marked at required exit doorways and where otherwise necessary to indicate clearly the direction of egress.
- If the sides of the tent(s) are down, the means of egress shall be illuminated with light having an intensity of not less than 1 foot-candle (11 lux) at floor level while the structure is occupied.
 Fixtures required for means of egress illumination shall be supplied from a separate circuit or source of power.
- > Hay, straw, shavings or similar combustible materials shall not be located within any tent.
- Smoking shall not be permitted in tents "No Smoking" signs shall be conspicuously posted.

- Open flame or other devices emitting flame, fire or heat or any flammable or combustible liquids, gas, charcoal or other cooking device or any other unapproved devices shall not be permitted inside or located within 20 feet of the tent.
- > Portable fire extinguishers shall be provided where any cooking is planned.
- > Cooking and heating equipment shall not be located within 10 feet of exits or combustible materials.
- Operations such as warming of foods, cooking demonstrations and similar operations that use solid flammables, butane or other similar devices which do not pose an ignition hazard, shall be approved before use.
- Cooking tents with sidewalls or drops where cooking is performed shall be separated from other tents by a minimum of 20 feet.
- > Outdoor cooking that produces sparks or grease-laden vapors shall not be within 20 feet of a tent.
- The storage, handling and use of LP-gas and LP-gas equipment shall be located outside the tent. Safety release valves shall be pointed away from the tent.
- Generators and other internal combustion power sources shall be separated from tents by a minimum of 20 feet and shall be isolated from contact with the public by fencing, enclosure or other approved means.
