## AN ORDINANCE AMENDING SECTION 13-502 OF THE MUNICIPAL CODE OF THE VILLAGE OF ARLINGTON HEIGHTS REGARDING VILLAGE LIQUOR LICENSES

WHEREAS, the Village of Arlington Heights is a home rule municipal corporation in accordance with Article VII, Section 6(a) of the Constitution of the State of Illinois of 1970; and

WHEREAS, the Village has the authority to adopt ordinances and to promulgate rules and regulations that pertain to its government and affairs; and

WHEREAS, pursuant to Chapter 13 of the Municipal Code of Arlington Heights, Illinois, 1995, as amended ("Village Code"), the Village sets forth rules and regulations for the licensing of, and sale of alcoholic liquor by, alcoholic liquor retailers in the Village; and

WHEREAS, pursuant to Section 13-502 of the Village Code, the Village limits the number of local liquor licenses available at any one time for each liquor license classification established by the Village Code; and

WHEREAS, the Village President and Board of Trustees desire to amend Section 13-502 of the Village Code to reflect the current number of licenses permitted within each liquor license classification; and

WHEREAS, the President and Board of Trustees has determined that it will serve and be in the best interests of the Village and its residents to amend Section 13-502 of the Village Code pursuant to this Ordinance;

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF ARLINGTON HEIGHTS:

SECTION 1. RECITALS. The facts and statements contained in the preamble to this Ordinance are found to be true and correct and are hereby adopted as part of this Ordinance.

SECTION 2. FEES AND NUMBER OF LICENSES. Section 13-502, titled "Fees and Number of Licenses," of Article V, titled "Fees, Classification, Hours of Operation," of Chapter 13, titled "Alcoholic Liquor Dealers," of the Village Code is hereby amended further to read as follows:

SECTION 4. PUBLICATION. The Village Clerk is hereby directed to publish this Ordinance in pamphlet form pursuant to the Statutes of the State of Illinois.

SECTION 5. EFFECTIVE DATE. This Ordinance will be in full force and effect from and after its passage, approval, and publication in the manner provided by law.
