Austin Mejdrich said he is a resident and part of the LGBTQ community. He asked the Board to adopt a proclamation for March 31st as a Transgender Day of Visibility. He said there is increased urgency this year as the Trans community has been under assault across the country. Adopting a proclamation would be an incredible and simple step and would build on the Board's legacy after recognizing Pride Month last year. He also urged the Board to reconsider the flag ordinance.

President Hayes said because of the number of proclamation requests we are receiving, at some point we have to say no. The Board would do nothing but issue proclamations if we said yes to all the requests. Our job is to provide basic services. We were not elected to support social causes. He said he worried about making proclamations on social issues and didn't want to get away from the primary issues.

Trustee Grasse said she hears Mr. Mejdrich and stands with him. She said it is important for a government to stand by all our residents. She said she believes it's our responsibility.

Trustee Canty agreed with Trustee Grasse and asked for staff to provide the number of requests we receive at some future time.

A. Ordinance - Sign Variation Extension - Arlington Approved
International Racecourse

Mr. Recklaus explained that in 2017 the racetrack requested an electronic billboard on Route 53 to add revenue and call attention to special events. There are eight similar signs in the Route 53 vicinity in neighboring communities. The request was approved with a few stipulations, one of which was to remove the billboard entirely if the racetrack ceased operations, which it now has. Churchill Downs staff remains on the site and will stay until the sale occurs which is not expected until 2023. Staff is recommending to maintain the sign until that time, and allow Churchill Downs to gain revenue in the interim.

Tony Petrillo, President of Arlington Park, said the facility is still pursuing trades shows and other leasing options during the transition. Having the electronic sign will help support the property. The remaining staff are supported by the sign revenue. The property continues to be used by the community as well.

Trustee Scaletta said the goal when crafting the restrictions on the sign was to make sure the Village had the opportunity, and the right, to make Arlington Park take it down. He said it made sense to leave it up as an option for the next user to be able to use the sign to its best benefit. At a later time, the Board can take it the issue up again. It is in the best interest of the Village and the Churchill employees that it remains.
