AN ORDINANCE AMENDING CHAPTER 13 OF THE MUNICIPAL CODE OF THE VILLAGE OF ARLINGTON HEIGHTS REGARDING HOURS OF OPERATION FOR ALCOHOLIC LIQUOR LICENSEES

WHEREAS, the Village of Arlington Heights is a home rule municipal corporation in accordance with Article VII, Section 6(a) of the Constitution of the State of Illinois of 1970; and

WHEREAS, the Village has the authority to adopt ordinances and to promulgate rules and regulations that pertain to its government and affairs; and

WHEREAS, Chapter 13 of the Municipal Code of Arlington Heights, Illinois, 1995, as amended ("Village Code"), sets forth rules and regulations for the licensing and sale of alcoholic liquor in the Village; and

WHEREAS, Section 13-503 of the Village Code establishes the permitted hours during which alcoholic liquor may be sold in the Village; and

WHEREAS, the President and Board of Trustees desire to amend Section 13-503 of the Village Code to revise the permitted hours of alcoholic liquor sales on Sundays; and

WHEREAS, the President and Board of Trustees have determined that it will serve and be in the best interests of the Village and its residents to amend the Village Code pursuant to this Ordinance;

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF ARLINGTON HEIGHTS:

SECTION 1. RECITALS. The facts and statements contained in the preamble to this Ordinance are found to be true and correct and are hereby adopted as part of this Ordinance.

SECTION 2. HOURS OF OPERATION. Section 13-503 of the Village Code is hereby amended further to read as follows:

SECTION 4. EFFECTIVE DATE. This Ordinance will be in full force and effect from and after its passage, approval, and publication in the manner provided by law.
