Subject: 2020-27: Wilke Road Resurfacing & Multi-Use Path – Project Cost Update

The Phase 1 Project Development Report prepared by Christopher B. Burke Engineering, Ltd. (CBBEL) was submitted to IDOT on August 11, 2022 and approved by District 1 on August 22, 2022. The report included an updated construction cost estimate, which was a significant increase from the original estimate. CBBEL also provided the Village a proposal for the Phase 2 engineering design portion of the project. The table below details the changes in cost:

After discussion with CBBEL and Kendra Johnson of the NWMC, it was agreed that the current \$120,000 in Federal funds allocated to Phase 2 engineering design would be re-allocated to Phase 3 construction/construction engineering (CON/CE). This will allow the Village to pursue Phase 2 design without having to involve IDOT in a consultant agreement, eliminating the months of time needed for the agreement approval, while still utilizing the full amount of Federal funding already allocated.

The project is currently programmed for design and construction in Federal FY2023. Since Phase 2 design has not yet begun, this timeline is unattainable. We will request the NWMC to reprogram the construction for 2024. This will still allow for a late fall/early winter 2023 letting, since the Federal FY2024 begins on October 1, 2023. A letting before the end of the year can hopefully bring better prices and scheduling for spring 2024 construction.

We will also be requesting additional Federal funding up to the maximum allowable \$3.5 million. According to Kendra, there is very little additional funding currently available, but in another year, it is possible other projects may be pushed back and free up additional funding. We'll send our request now to be first in line.

Since Rolling Meadows is partnering with us on this project, we have updated them on the cost increases and will work out the IGA for the Phase 2 design contract.

The tables below show an estimated breakdown of funding sources, based on the previous cost estimate and the updated cost estimate. The percentages for the local share split are based on the Phase 1 IGA with the City of Rolling Meadows (CRM).

The increase in costs will require a budget increase for this year to fund the Phase 2 Engineering. The 2023 CIP includes \$997,000 for Construction and Phase 3 Engineering and although the project will be shifted to the Federal FY2024, it will still be in the Village's FY2023 budget.

The 2023 proposed budget will reflect the cost increases to construction and Phase 3 engineering.
