AN ORDINANCE AMENDING THE COMPREHENSIVE PLAN OF THE VILLAGE OF ARLINGTON HEIGHTS

WHEREAS, in Petition Number 22-007, on October 26, 2022, pursuant to notice, the Plan Commission of the Village of Arlington Heights conducted a public hearing to consider an amendment to the Comprehensive Plan, which includes a change to the land use designation for a portion of the property located at 1330 N. Douglas Avenue, Arlington Heights, Illinois and legally described in Exhibit A attached to and, by this reference, made a part of this Ordinance ("Property"); and

WHEREAS, the President and Board of Trustees have reviewed the minutes of the Plan Commission hearing and determined that the amendment to the Comprehensive Plan is in the best interests of the Village of Arlington Heights,
