

AN ORDINANCE APPROVING A \$1.6 MILLION  
PARTIAL ABATEMENT OF THE 2022 TAX LEVY

WHEREAS, on December 5, 2022, the Board of Trustees of the Village of Arlington Heights, Cook County, Illinois, adopted Ordinance No. 2022-064 (“*2022 Tax Levy Ordinance*”), providing for the levy and collection of a direct annual tax on all property within the corporate limits of the Village, in the amount of \$38,043,000 for the Village and \$14,828,000 for the Arlington Heights Memorial Library, for a total amount of \$52,871,000 (“*2022 Levy*”), and directing the County Clerk of Cook County, Illinois to ascertain the rate required to produce said tax for the 2022 Levy; and

WHEREAS, the Board of Trustees of the Village now desires to approve a partial abatement of the 2022 Levy provided in the 2022 Tax Levy Ordinance;

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF ARLINGTON HEIGHTS:

SECTION 1. RECITALS. The facts and statements contained in the preamble to this Ordinance are found to be true and correct and are hereby adopted as part of this Ordinance.

SECTION 2. APPROVAL OF A \$1.6 MILLION PARTIAL ABATEMENT AND EXTENSION. The 2022 Levy is hereby abated in part, as follows:

- A. For the Village’s Police Protection portion of the 2022 Levy: the amount of \$800,000 is hereby abated, and the remaining amount of \$5,950,000 is to be extended for collection; and
- B. For the Village’s Fire Protection portion of the 2022 Levy: the amount of \$800,000 is hereby abated, and the remaining amount of \$5,950,000 is to be extended for collection.

SECTION 3. FILING. The Clerk of the Village of Arlington Heights is directed to file with the Clerk of Cook County, Illinois a copy of this Ordinance duly certified under the Corporate Seal of the Village of Arlington Heights as provided by law, and the County Clerk is requested and directed to partially abate the 2022 Levy of the Village of Arlington Heights, Cook County, Illinois, as set forth in Section 2 of this Ordinance.

SECTION 4. PUBLICATION. The Village Clerk is hereby directed to publish this Ordinance in pamphlet form pursuant to the Statutes of the State of Illinois

SECTION 5. EFFECTIVE DATE. This Ordinance will be in full force and effect from and after its passage, approval, and publication in the manner provided by law.
