# PROJECT DESCRIPTION 1821 NORTH VERDE AVENUE ARLINGTON HEIGHTS, ILLINOIS PIN's: 03-19-104-001-0000 and 03-19-104-002-0000

The Application is to change zoning for 1821 North Verde Avenue, Arlington Heights, Illinois from R-1 to R-3, One Family Dwelling District. The Petitioners, John Van Kooten and Annie Van Kooten also seek approval from the Plan Commission of Arlington Heights to sub-divide two lots for the purpose of constructing two (2) new single-family Homes (each Home will have a North Verde Avenue frontage).

The Petitioners will demolish the existing cape cod style home, which is currently in very poor condition with slab and foundation defects, rendering the property inhabitable.

The two proposed new single-family dwellings will each be two-story with a finished basement and garage. Each Home will be constructed using masonry brick and frame. Each home will have open-yard green space.

A Detention is not required on this small proposed resubdivision.

After construction, Petitioners plan to market the two new Homes to the public. The estimated list price for each Home will be between \$750,000.00 to \$850,000.00.
