A RESOLUTION APPROVING A MEMORANDUM OF UNDERSTANDING WITH THE
FEDERAL BUREAU OF INVESTIGATION FOR PARTICIPATION IN THE
NORTH SUBURBAN SAFE STREETS TASK FORCE

WHEREAS, the Village is a duly organized and validly existing home rule municipal corporation created in accordance with the Constitution of the State of Illinois of 1970 and the laws of the State; and

WHEREAS, the Constitution of the State of Illinois of 1970, Article VII, Section 10, authorizes units of local government to contract or otherwise associate with individuals, associations, and corporations in any manner not prohibited by law or ordinance; and

WHEREAS, pursuant to the Illinois Intergovernmental Cooperation Act, 5 ILCS 220/1, et seq, the Village is authorized to enter into agreements with other units of government; and

WHEREAS, the Federal Bureau of Investigation (“*FBI*”) intends to coordinate the North Suburban Safe Streets Task Force, an inter-agency initiative comprised of federal, state, and local law enforcement agencies in northeastern Illinois, to maximize resources between participating agencies for policy guidance, planning, training, public and media relations (“*Task Force*”); and

WHEREAS, the Task Force collaborates to investigate, apprehend, and prosecute criminal enterprise groups and dangerous fugitives responsible for drug trafficking, money laundering, smuggling undocumented individuals, and crimes of violence; and

WHEREAS, the Village and the FBI desire to enter into a memorandum of understanding regarding the formation and operation of the Task Force (“*MOU*”); and

WHEREAS, the President and Board of Trustees of the Village find that entering into the MOU with the FBI is in the best interests of the Village and its residents;

NOW, THEREFORE, BE IT RESOLVED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF ARLINGTON HEIGHTS, COOK COUNTY, ILLINOIS, as follows:

SECTION 1. RECITALS. The facts and statements contained in the preamble to this Resolution are found to be true and correct and are hereby adopted as part of this Resolution.

SECTION 2. APPROVAL OF MOU. The President and Board of Trustees hereby approve the MOU in substantially the form attached to this Resolution as Exhibit A, and in a final form to be approved by the Chief of Police and the Village Manager.

SECTION 3. EXECUTION OF MOU. The Chief of Police is hereby authorized and directed to execute, on behalf of the Village, the MOU and all necessary documentation related thereto.

SECTION 4. EFFECTIVE DATE. This Resolution will be in full force and effect from and after its passage and approval as provided by law.
