

**MINUTES OF THE COMMITTEE-OF-THE-WHOLE MEETING OF THE
PRESIDENT AND BOARD OF TRUSTEES OF THE
VILLAGE OF ARLINGTON HEIGHTS
May 20, 2024**

President Hayes called the meeting to order at 7:00 PM.

A. Interview of Sydney Galla for appointment to the Youth Commission (youth member), term ending April 30, 2025.

The Mayor introduced Sydney and stated she is a freshman at a local high school and that the last name may be familiar as her mother is very involved in the community.

The Mayor stated that he would like to take the two candidates for the Youth Commission at the same time. Trustees thanked both Sydney and Michael Bauer for their willingness to serve. The Trustees asked what was one issue that they saw that really affects youth today.

Sydney stated she feels that the youth today are really affected by technology and by social media. She feels that social interactions and relationships are affected by this and it is an area that many youth struggle with. Michael Bauer also felt strongly about this area and believes it is important for a variety of in person gatherings and discussion ensued.

Trustee Grasse moved to concur in the Mayor's appointment of Sydney Galla for appointment to the Youth Commission (youth member) term ending April 30, 2025. Trustee Tinaglia seconded the motion.
