3. What capital improvements would you and your family like to see in the next 3-5 years? Capital improvements include the construction of new facilities, remodeling or expansion of existing facilities, and the purchase, improvement and development of land.

Improvements to Recreation Park basketball courts and pool. Make outdoor basketball courts at Recreation park to similar to the Pioneer Park outdoor basketball courts.

I would like to see some changes made at the Recreation Park Pool. Maybe not the extent that was slated for the referendum, but the building needs an upgrade. I would also be interested in a dog park.

Indoor gym facility

Improvements/additions to Recreation park

More basketball options for open gym or keep it going. Make an outdoor basketball court at Recreation Park that is of the same level as Pioneer park.

Wheel chair access

Teardown Recreation Park's building, and put in one main building. More basketball, volleyball, and dance areas, which are then in the center of the village, and not at the far north end or in Prospect Heights for us citizens. Rec Park's building is useless, and far too out dated. Leave the satellite park buildings alone.

Keeping Rec Park up to date. During our 19 years in AH, every other park district facility has been renovated/remodeled, except Rec. Rec Park is crucial to our community with Frontier Days and it'd be nice to see it updated to be used more throughout the year.

Remodeling of Rec Park, similar to how Pioneer was redone.

Remodeling of Rec Park, specifically the basketball court.

We would love to see Rec park get updated and made accessible to strollers, etc. We would love to see a splash pad or some sort of zero depth pool would be ideal!

Remodeling of Recreation Park pool and grounds. I would like to see some sort of volleyball and new basketball area as well.

Good playgrounds with fun equipment and nice places to sit with shade

The Park District provides a full range of recreational activities, a public open space system, recreational facilities and special events for its citizens. Recreational facilities operated by the Park District include 58 parks, totaling 715.09 acres, with one indoor and five outdoor swimming pools, five community centers, a cultural arts center, historical museum, Forest View Racquet and Fitness Club, Heritage Tennis Club, Arlington Lakes Golf Club, Nickol Knoll Golf Club, Lake Arlington, Melas Park Sports Complex, and an assortment of softball diamonds, football and soccer fields, playgrounds, and picnic areas.

These essential community features enhance the social, physical, and psychological well-being of citizens by providing them with enjoyable activities and settings in which to spend their leisure time. The economic benefits of preserving open spaces and offering recreational opportunities include increase in the value of surrounding properties and enhanced quality of life in Arlington Heights.

The Park District uses the following classifications as guidelines to develop an equitable system of parks, recreation facilities and natural open space for the Park District. The classifications are based on previous guidelines from the National Recreation and Park Association (NRPA) adopted by the Park District in 1982. The six classifications are Mini Parks, Neighborhood Parks, Community Parks, District Parks, Special Facilities, and Connector Parkways. These are summarized, along with the detailed description of each park classification; this section also presents the level of service standards for each park type and the justification for those standards.

These standards have been adopted by most cities across the United States and are designed to allow for an equitable distribution of park resources. These standards are easy to apply and have been tested in the courts. The minimum recommended standard for an urban area is 10 acres per 1000 residents. Applying this minimum to Park District would require a total of roughly 769 acres of developed park land. Park District presently has approximately 715 acres of developed park land, which indicates that the Park District has a deficit of approximately 50 acres of developed park land.

The Park District refines this standard of 10 acres per 1000 residents by dividing this acreage into:

#### Mini Parks

These parks are developed in denser multiple family neighborhoods as a way to provide immediate recreational opportunities in these areas that lack neighborhood parks. These are smaller sites, usually less than two acres, equipped with playground apparatus conducive to the recreational activity of young children. Mini parks have a service radius of a one-quarter to one-half mile.

#### **Neighborhood Parks**

A neighborhood park is generally anywhere from two to ten acres in size, serves a population within a one-half mile to one-mile radius, and is centrally located within the neighborhood it serves.

Neighborhood parks should be developed at a minimum of one acre per every 1000 residents. A neighborhood park is designed to serve a pedestrian population, and its facilities usually include playground apparatus, athletic field areas, and an area for passive recreation.


### Section 3: Overview of Resident Survey Responses

#### **Key Survey Findings**

Finding #1: By a wide margin, walking and biking paths are the current parks, paths, and facilities that Arlington Heights Park District household respondents feel should receive the most attention from the Arlington Heights Park District over the next three (3) years. Neighborhood parks, outdoor swimming pools and large community parks were the next three highest rated parks, paths, or facilities to receive attention.

Respondents were provided a list of 27 different parks, facilities and services and asked to indicate the top 4 that should receive the most attention from the Arlington Heights Park District.


10 Parks, Paths, and Facilities that Should Receive the Most Attention Over the Next 3 Years



In every geographic area, walking and biking paths was the highest ranked parks, facility or service for emphasis and small neighborhood parks were among the top 3 highest ranked for emphasis


Finding #3: Participation in programs and activities is high across all geographic areas with opportunities to increase frequency of participation. 54% of respondents for the entire Park District have participated in programs with participation in programs being at least 43% in all geographic areas. Most households who participated in programs and activities participated in 1-3 programs and activities during the past 12 months.

Over the Past 12 Months What Percent of Households Participated in Programs and Actitivies of the Arlington Heights Park District?




Finding #10: In the entire Arlington Heights Park District and every geographic area, walking and biking paths were the first most important park or facility and small neighborhood parks were the second most important park or facility, with the exception of Recreation where neighborhood parks are third most important and outdoor swimming pools second most important.

From a list of twenty-seven different parks and facilities, household respondents were asked to indicate the four parks and facilities that were most important to them. The chart below shows the 5 parks and facilities that were selected by the highest percent of households based on households in the entire Park District. The chart also shows what percent of households in each of the geographic areas selected each of the parks and facilities in the sum of their top 4 choices.



Finding #12: Out of fifteen potential projects, respondent households were asked to indicate the 1<sup>st</sup>, 2<sup>nd</sup>, 3<sup>rd</sup> and 4<sup>th</sup> most important projects for their household. As shown in the chart below, based on a sum of their top 4 choices, enhance/develop walking and biking paths (52%), upgrade Lake Arlington (41%), develop additional recreation, fitness and cultural program spaces for active aging adults (35%) and renovate Olympic Indoor Aquatic Center (32%) were the most important projects. Additionally, shown on the chart is the percentage of households in each geographic area who selected these projects as one of their Top 4 choices.





**Comment:** Message: Hi, I cannot make the meeting tonight regarding Rec Park renovation. I was hoping pass along some thoughts.

First, I am SO GLAD that Rec is getting attention! It really needs it and it is in the heart of the town and attracts so many people for Frontier Days and swim meets and baseball. The park should reflect the modern loveliness that the rest of the village center has.

I am also glad that you are planning to keep the historic WPA building.

A few of the proposed ideas that I think deserve a second look:

#### (Ben Rea's replies in blue. This message was received via Contact us on 8/23/22)

Why eliminate a tennis court and replace with bags - everyone has their own bags and can play it anywhere. Tennis is hard to find. Presently, the park district maintains 43 tennis courts in the community. That is about 5 over the minimum requirement set by the National Recreation and Park Association. The idea behind the lawn games (bags or something else) is to provide a recreation opportunity for all to utilize, as well as provide a recreational amenity that scores well on the grant application.

It is dumb to have a grand entrance from the SW corner - no one comes to the park from that direction. The access points from the southeast and southwest corners need to be created to provide a connection to the park's pathway. Most likely there will be a park sign and some enhance landscaping to welcome people into the park.

The playground is relatively new. Why change it? The playground was installed in 2011. The proposed playground is fully inclusive and will serve people of all abilities. Presently, the park district does not have a fully inclusive playground. Recreation Park is a great location, given the close proximity to the center of town. Would love a nature path/walking path around the perimeter landscaped with native flora. There are plans to introduce rain gardens throughout the space utilizing native plantings.

Comment: My priority for Rec Park is to maintain and improve upon what we already have. And for it to continue being a neighborhood park! I would rather not see drastic changes, while I do agree and understand that some new elements are positive. I think having 3 tennis courts in approximately their current position is important. I also encourage the Park District NOT to remove any of the large trees in that area (left field of baseball diamond) in order to re- envision that use of space. I would greatly appreciate the PD's commitment to provide continuing to provide a large, free skate, ice skating rink in its historic location in winter time- in the past the pool has doubled as a warming house, ant that would be fun to bring back and maybe add to/or renovate the existing structure, rather than tearing it completely down. Our neighborhood ice rink is cherished here at Rec! The pool is amazing as-is, but the baby pool leaves something to be desired. Great if that re-innovation could be part of Phase 1!

Please keep Frontier Days in our park! Also: preschool at Rec Park is a high priority! This is our neighborhood park and we would like its focus to still be on serving the neighbors.

**Comment:** Hi Tyler, Thank you for talking with me today at the park. Here are a few of my comments about the Rec Park Concept that I wanted to share with you.

- 1. Permeable paver parking lots In our community in Wisconsin we repaved our roads in our subdivision with permeable pavers and it has been far more work than ever imagined. You need to sweep with equipment and refill a couple times a year. There is a lot of growth in between bricks.
- I imagine you decided on permeable pavers so people wouldn't be upset with taking our greenspace for a parking lot but I don't think it's the right move.
- 2. Tennis Courts The tennis courts at Rec at high times are always busy. I know someone mentioned that AH has more tennis courts on average than other areas but that doesn't help because Rec Park is a hot spot for tennis. My suggestion would be not only to have 3 courts but many even ADD a court or pickleball courts. I think if we look at trending sports pickleball is rising!
- 3. What is the reason to have a parking lot right next to the park in the middle of the neighborhood? It's dangerous for kids going to the park. If anything, there are far better spots for the parking lot like right on

Northwest HWY and Belmont or in front of what's labelled "T - Future space". Parking lots do not need to be in the middle of a neighborhood. We have far too many issues with cars on Belmont/Miner and Wing and Belmont. It's scary. We don't need another reason for cars to be closer to the park. **Comment:** Some of the new features in the latest Concept Plan for the redevelopment of Recreation Park are welcomed and long overdue. However, this plan has several components that will be very difficult for my fellow residents in the Rec Park Neighborhood to support and endorse. Based on conversations with the park district officials in attendance at the open house this past week and numerous conversations with other Recreation Park neighbors, here are my concerns and suggestions:

\* The additional parking lot on Belmont is unnecessary and potentially dangerous. Currently, all of the parking for the amenities in the park are on non-residential streets. Building a parking lot on an already relatively busy Belmont Avenue will create safety concerns for residents in the immediate area and the majority of people who walk to the park. If Village officials are requiring these additional parking spaces (as stated by park district officials at the open house), Recreation Park neighbors will voice strong opposition at Village Board Meetings.

Neither the playground or the tennis courts are destination amenities. Other parks currently have equal or better playgrounds, tennis courts, and basketball courts. Most people walk from the neighborhood to these park features. The few visitors who drive to the playground or to play tennis can continue to park on the street as they have done since the park was built.

The lack of parking has never been an issue in this area of the park. More importantly, creating more pavement in the form of parking is not where the country is heading environmentally. Encouraging people to drive to a recreation facility adds to the carbon footprint of the park instead of reducing it. This alone is a valid reason to eliminate this proposed parking lot. If ADA parking spaces are needed for the accessible playground, designated spots could be added on Belmont Avenue immediately adjacent to the

playground. (THIS PROPOSED PARKING LOT IS A NON-STARTER FOR THE NEIGHBORS. WE WILL USE EVERY OPTION AT OUR DISPOSAL TO PROTEST THIS FEATURE OF THE PLAN)

- \* Eliminating the parking lot on Belmont will allow the tennis facility to maintain three courts, not the scaled down version of two. I play tennis regularly on these courts. It is often difficult to secure a court on evenings and weekends. I suggest leaving the courts where they are or relocating the three courts in the proposed parking area. If the tennis facility is re-oriented parallel to Belmont Avenue in the same footprint as the proposed parking lot, pickleball courts could be added where the two tennis courts are proposed. This would be well-received by the Rec Park neighbors. (REDUCING THE NUMBER OF TENNIS COURTS IS A NON-STARTER FOR THE NEIGHBORS. WE WILL USE EVERY OPTION AT OUR DISPOSAL TO PROTEST THIS FEATURE OF THE PLAN)
- \* The skate park is another unnecessary new feature. Skate parks are closing in the area due to decreased demand. The proposed size and configuration of this feature will not make it a destination amenity that will draw skaters from the greater Northwest Suburbs. Municipalities like Park Ridge have found these skate parks are targets for vandalism. Unless the Park District has current and valid studies showing the demand for this amenity from Rec Park neighbors, this feature should be eliminated.
- \* The current parking adjacent to Lloyd Meyer Field has historically been the most underutilized area in the park. Very few people park there when they visit the pool and smart parkers avoid this lot during baseball games. I played on the baseball field for many years and always questioned why this lot was built so close to a full-size baseball field. No netting plan would avoid balls landing in the current or proposed downsized lot. I agree the parking lot should be downsized, but the 50 spaces should be relocated to "Area T" on the Concept Plan.

The green space that is lost in "Area T" could be moved to the proposed downsized parking lot area. This would eliminate the safety and car damage issues from balls leaving the field of play. It would also provide more green space for baseball fans to set up their chairs and blankets. Children will also be able to play in this area when they are attending games. Other than the bleachers, there is currently very little green space for spectators. (RECREATION PARK NEIGHBORS STRONGLY SUGGEST RELOCATING THE PROPOSED DOWNSIZED PARKING LOT)

\* The pool house is architecturally and historically significant. I would encourage the Park District to save this structure and renovate the common area, guard house, and locker rooms. This would allow for more creative and efficient use of a renovated field house building. (RECREATION PARK NEIGHBORS WILL STRONGLY CHALLENGE THE DEMOLITION OF THIS LANDMARK STRUCTURE)

I appreciate the opportunity to comment on the Concept Plan. I look forward to reviewing a revised plan. Thank you

Perhaps you don't realize but tennis is growing rapidly in popularity by double digit percentages yearly. Tennis is the perfect social-distancing sport—and the numbers continue to prove it. The survey and report monitor more than 120 different sports and activities participated in by Americans.

Of the more than 21 million Americans saying they played tennis last year, 6.78 million were either new or returning/lapsed players. Nearly 3 million of those were first-time players, a 44% increase over new players in 2019. Additionally, the 3.82 million Americans who returned to the sport after time away was a 40% increase over the same measure in 2019.

"When we proved to the world that we could have over 13,000 [COVID-19] tests and 99.97 percent of them were negative... I think we demonstrated that if you do it properly, tennis is absolutely a safe sport to play," says Michael Dowse, chief executive officer and executive director of the United States

#### Tennis by the Numbers

At the recreation level, activity throughout the past year suggests that people have taken to the sport during the pandemic, and the numbers confirm it. Annual data shows significant growth in racquet sales and tennis participation across the United States. Tennis participation in the country increased by 22 percent in 2020, with 21.64 million people hitting the courts, according to data from the Physical Activity Council's

(PAC) <u>Participation Report</u> produced by Sports Marketing Surveys. The survey and report monitor more than 120 different sports and activities participated in by U.S. residents (see charts below).

Of the more than 21 million Americans who say they played tennis last year, 6.78 million were either new or returning players.

"We are thrilled that so many new and existing players came back to the sport — especially in what was such a challenging year for so many people," says Dowse. "These new participation numbers are a testament to the hard work, passion and commitment of a united industry that worked together to ensure that tennis not only survived, but also thrived.

"Even though we continue to face challenges, it's evident that many people recognize tennis as the ideal social-distancing sport, which puts it in a great position to continue to grow and allow people to stay active and social in a healthy and safe manner."

Tennis' positive health impacts are well-documented. The report, <u>Health of Tennis Industry 2020</u> published in the July 2020 edition of the <u>Journal of Medicine and Science in Tennis</u>, shows that those who play the sport have better general, physical, social and mental health than the general population.

"We are excited to see these positive trends and such significant growth in our sport," says Craig Morris, USTA chief executive, community tennis. "We are energized to continue putting forward key industry partnerships and quality programming to ensure new and existing players of all ages and abilities have the best experience playing the sport for a lifetime."

#### The Sport's Impact on Recreation

Self-contained facilities have been among those that are reaping the benefits of the boom. The courts were resurfaced in 2019 with the help of a \$20,000 USTA facility assistance grant and have been the cornerstone of a vibrant community. Since reopening in July 2020, the park has seen its courts full from morning to dusk, booked on a first-come, first-served basis.

"The community was so ready to get the courts up and running again," says Mohammad El-Haj Ahmad, president of the Fort Greene Tennis Association (FGTA), which has a 10-person board of volunteers that guides decision making, funding and scheduling for the tennis center.

Pre-pandemic, a line of 20 to 30 people would be a good turnout for a sunny weekend day, he explains. Now, they see upwards of 50 on a regular basis, and as many as 70 on busy days. "It was incredible to see how it went from nothing to full in just a few hours."

The Querbes Tennis Center in Shreveport, Louisiana, celebrated a grand reopening in late February 2020 after major renovations, aided by USTA grants. After just two weeks of play, the center shut down due to COVID-19. But any concerns about revenue loss were quickly diminished once it opened again in May 2020. This single, 11-court tennis club saw roughly 250 new players by year's end, including some 150 kids. In both July and August, more than 2,000 players took to the courts in Louisiana's northwest corner.

"It has really been a perfect storm," Chris Dudley, tennis director at Querbes Tennis Center, says of the combination of the brand-new facility and tennis' boom as a physical-distancing sport.

Statistics show tennis is growing in popularity and a reduction in courts at Rec Park seems counterproductive and counterintuitive to me. When roads become congested and/or over crowded, they get expanded not reduced. When schools get overcrowded, school districts want to expand - just like school district 25 here in AH.

We have over 30 players (and growing) of various skill levels in our tennis group and we pay for permits for 2 courts at Rec and Pioneer Parks (about \$1,500) during the summer months. Our season runs from St. Patrick's Day weekend through Thanksgiving weekend so we use both parks A LOT! With so many players in our group, we need more courts not fewer courts.

I feel there is more than enough room for 4 courts under the new master plan from looking at the artist's rendering (attached). For one, the proposed parking lot could be altered a little to accommodate a few less cars (say 18 stalls instead of 22) and I don't see the need for an area for the bag toss games. If bags are that popular, perhaps move or relocate the bag games to the "future development" area (T) and maybe install or include some volleyball courts there too like at Heritage Park. Throw in a few bocce balls courts as well and be the first on the block to offer bocce ball, lol. Food for thought, adding new features instead of reducing a very popular one.

I/we ask that you please reconsider the reduction of tennis courts and instead please increase the number to 4. The reduction to 2 will effect a hell of a lot more people then you think! Let's increase, not decrease this vital park asset. 4 courts will help make Rec Park the crowning jewel that it is. Besides, the park district does provide various levels of tennis instruction. Where are all of these new and existing players gonna play? If you're gonna teach them to play tennis - don't you need more facilities for them to play on instead of less? In addition, courts used for instruction (per park district rules) take away from the number of courts needed/wanted for recreational tennis.

We all pay plenty of park district taxes and I appreciate you taking time to read this email and seriously ponder a different decision. Even resurfacing or redoing the current 3 courts would be a far better alternative then the reduction of courts. Thank you for your time, P.S. If the courts are reduced to 2, too many people will never get to play.

I remain hopeful that the designers would be kind enough to take into considerations the actual needs of the patrons and only add improvements to the park without taking away and destroying a valuable, favorite, and well-used part of Rec Park – its 3 tennis courts with lights and a big wall that help players improve their strokes.

Comment: Message: Dear Arlington Height Park District Board Executive Director and Commissioners, I am an Arlington Heights resident who attended Arlington and Prospect High Schools. I have been a teacher in School District 25 for 24 years. My husband and I have raised our three children in Arlington Heights and love our village! My parents and our married siblings also live in Arlington Heights. I have many friends here, and one of my favorite things to do is to play tennis. I am writing because I think it is important for there to be three or four tennis courts built at Recreation Park when it is remodeled instead of only two. I could hardly believe it when I found out that the current plan is for the building of only two tennis courts. There have been three courts at Recreation Park for as long as I can remember, and these courts are I started playing tennis with several Arlington Heights neighbors about 15 years ago, and we have been playing mixed doubles tennis at Recreation Park every week ever since. We meet and play whenever the weather is above 50 degrees and dry, generally from May through November. We have an annual tradition of playing every year on Thanksgiving morning as our last session before winter. Our group has grown in numbers from around 10 to over 40 people. Not all 40 people show up to the tennis courts on any given day, but we often have close to 20 people drop in and play. We almost always need all 3 courts, and we play for two hours. The leader of our group sends out emails at least weekly.

In recent years, the tennis courts at Recreation Park and Pioneer Park have become so popular that we as a group have put a reserve on the courts through Heritage tennis club. It is nearly impossible to get the courts to play on unless we do that. The courts at Pioneer are extremely popular, and they are used by people consistently during the evenings and weekends. One reason for this is because there are 4 courts. When a group of people shows up, they know they will probably have a chance of getting a court.

Recreation Park is centrally located in Arlington Heights, and I am sure that if four courts were built, they would be popular and well-used by Arlington Heights residents. I play with other tennis groups as well, and it is very important to have at least three tennis courts. By only building two tennis courts, groups like ours would no longer be able to play. Two courts are not enough for us.

Please let me know if you would like to meet in person to further discuss my recommendations. I would be incredibly disappointed if a renovation to Recreation Park decreases existing tennis options for its faithful residents. We absolutely need three or more courts. Dear Mr. Meyer: Thank you so much for your time, work, and sincere care for the AHPD patrons.

I recently heard about the OSLAD capital project for Rec Park in Arlington Heights, the changes concerning the tennis courts and I am really concerned about the corresponding consequences for the tennis players (kids and adults) in the neighborhood.

Reducing the number of tennis courts when all tennis players in the neighborhood expect them to be increased is very disturbing! There are specific times when it is impossible to get a chance to play tennis. My husband and I often get to play after 9pm and this is the reason I would like to ask you if you are planning to keep the lights on our courts. They significantly increase the playing time on the courts. Another great asset that our tennis courts have and cannot be found in the other nearby courts is the big practice wall. You cannot do much on a small one, ours is perfect and I do hope you plan to keep it.

I was sure that there was some really good reason for the decision to eliminate a tennis court in Rec Park but when I reviewed the design, I saw that the existing tennis courts must be moved and reduced to two to make space for creating 22 additional parking stalls. This really surprised me as the existing parking lot with 50 parking stalls, next to the tennis court, is always empty. There are numerous parking stalls along N Douglas Ave (there are no houses in that part of the street) which people like to use and thus leave the parking lot empty. On the other hand, the tennis courts are well-used and there are too many cases where you can wait for hours on end and still not get a chance to play tennis. Also, in the summer, Heritage Tennis Club always uses one of the tennis courts for their evening group lessons.

If you reduce the number of the tennis courts in Rec Park, it will leave all tennis players in the neighborhood very disappointed as, in reality, the chances to play tennis in Rec Park will be reduced even more. When we have to wait too long, we used to go to Lions Park in Mt prospect, where the tennis courts are eight, but last Friday, we did not have a chance to play there as well. All eight courts were busy all the time.

My family, like many others that we know, started playing tennis during the pandemic when everything else was closed and the options to stay active and healthy were limited. Team sports that do not require close contact are not too many and the isolation during the pandemic, as we all know, was a big issue. Tennis saved our mental and physical health during the pandemic. As I learned later it is one of the sports that are best for cardiovascular health.

I do hope it is important for all people involved in that project that they take into consideration the actual needs of the patrons and when planning the improvements in Rec Park, make sure they do not take away and destroy assets that are immensely treasured, enjoyed and currently greatly appreciated by the patrons.

I remain hopeful that the design of the project would be revised and the open spaces usage in Rec Park would be optimized so that our most treasured assets that could not be found in the other nearby parks – three tennis courts with lights and a big practice wall - are kept and taken care of. As I told you, I really like all the proposed improvements to Rec Park but a reduction in tennis courts would be a severe blow. After speaking with you, I can tell the addition of a 4th court would probably be unrealistic if the park district is trying to reduce the overall number of tennis courts park district wide. However, I feel keeping 3 courts at a popular park is not only necessary but is the right thing to do with the high volume of use

those/these courts get. Currently, we normally have at least one verbal confrontation or altercation a month at Rec.

This morning, Saturday, there were 18 of us at Rec Park playing tennis so we played on all 3 courts and still had 6 people waiting to rotate in. Let me explain something. With our group of about 35 players, not everybody shows up all the time but it's not unusual to have double digit players. We do not play matches or sets but rather play only 1 game at a time and rotate players in and out after each game, everyone gets to play that way. There have been many occasions where we have filled all 4 courts at Pioneer Park and still had several folks waiting to rotate in. Because of the amount of players we have, we pay a lot of money for permits for 2 courts at Pioneer and 2 courts Rec Parks so we are guaranteed courts to play on. Even with the 2 reserved courts at each park we still have many players waiting to rotate in.

If Rec Park reduces courts down to 2 then I'm afraid our group would no longer be able to play there, just wouldn't be enough room to accommodate our numbers/size. We would be displaced and forced to find courts elsewhere, either in AH or neighboring towns. That would be a shame after playing at Rec for many, many years. Hello all, I had a pleasant and informative conversation with Ben Rea (Director of Parks and Planning) this morning and I was able to voice our concerns about the proposed 2 courts and was able to gather some information from "their" side to try to understand the reasoning in the court reduction.

First, Ben said they (the park district) have received about 57 emails so far concerning Rec Park and have been forwarding them to the board. He said the board is well aware of interests in general, not just the tennis courts but the renovation in general. Second, he is working closely with Carrie Fullerton, Executive Director, concerning issues with the courts. Third, this project is still just in the "concept stage" and is far from anything written in stone or finalized and they (the board) is more than willing to listen to concerns and thoughts. They are not opposed to keeping 3 courts or adding a 4th but more on that later in the email.

Ben did bring up some points that explained "the why" or the thought process or the reasons behind the reduction of courts from 3 to 2.

Oddly enough, the reduction in courts is not solely based on money or cost (even though it is a concern and a factor) but rather based more on overall park aesthetics and inclusivity. By that he means is one area of concern is making the playground more inclusive and accessible so those in wheelchairs or walkers can have easier access. In addition, they want to have a central corridor (walking path) running east to west that cuts the park in half, allowing better access to the western edge of the park from the eastern parking lot. They want to open up the park more and allow ease of movement from parking lot to parking lot. (That fits in with the other pathways they want around the park) The east parking lot is going to be the main parking lot for the park.

They want to put in a small parking lot next to the playground for a couple of reasons. One, to make handicap parking and general parking available for the playground and that area of the park. Two, to ease street parking which leads into reason three and that is hopefully open up better site lines to perhaps prevent any kids from running in between cars and out into the street and getting hit by a car. So it's a convenience factor and a potential safety issue.

Because they want to put the parking lot next to the playground where the tennis court are currently the courts would be moved south a little bit but are restricted in open real estate because of the land owner (lot 10 on the drawing). If he is ever willing to sell, the park district is willing to listen but until then nothing.

Here's where it gets interesting and probably our biggest road block or obstacle.....too many tennis courts already in existence in Arlington Heights! Yup, you heard me right. According to Ben, they have too many courts per capita according to the NRPA, National Recreation and Park Association (of which they are a card

carrying member). Currently there are 43 tennis courts available within the park district limits and that's including the ones they have already re-configured or reduced (i.e. Green Slopes) to include pickle ball courts. According to the NRPA and their "rules" or guidelines, a town/city the size/population of Arlington Heights should have 37.5 courts. Again, according to Ben, that figure of 37.5 courts is based on 1 court for every 5,000 people. How the NRPA came up with that ratio, he doesn't know.

So, as it stands now, Arlington Heights has 6 more tennis courts then they should have and the park district wants or "prefers" to "slim down" close to that 37-38 number. Guess what? That's why they reduced the courts from 3 down to 2 - to help eliminate an "access" court and help get closer to 37-38. However, like I said, Ben did say the park district is not totally opposed to having/keeping 3 courts but adding a 4th would probably not gonna fly. Adding a court when they are already over the NRPA's "quota" seems highly unlikely unless they do major cuts somewhere else. (ya, right)

Another issue we're going up against is of course money. It's not necessarily the cost to build 3 new courts (or add a 4th), it's the upkeep and maintenance down the road a few years that they have to be cautious about. All the courts in Arlington Heights have issues and the board is trying to do their due diligence spending money as evenly and effectively as possible on every park - not just tennis courts. 2 courts are "cheaper" to maintain in the future than 3 basically.

He said the tennis courts at Rec were built so long ago (1930's?) and were shoddily built (the substructure) and that's why cracks, paint problems, etc. redevelop after only a year or two. Unless the courts are destroyed and rebuilt, the park district will always have this dilemma (it's the problem or cause at all the parks that are severely "damaged"). Not to say the new courts won't have issues, they'll just be better built (within code so to speak) and maintenance issues should be less. They aren't gonna spend a lot of money now on courts that are destined to be destroyed in a few years. Any work to be done or is being done is basically for aesthetics only and not meant for major repair.

Ben told me that the cost to color coat Rec tennis courts (they're currently in the process) was/is \$100,000. He says the park district bids out all construction/repair work.

After talking with Ben, it is my opinion that the amount of courts already in existence in Arlington Heights (43) is our toughest and biggest roadblock to overcome, not necessarily money - but finances are definitely in play (maintenance mostly). Sounded like the park district is pretty much set on court reductions to get down to NRPA's guidelines. However, I also feel if we make our case strong enough (and others do too) - keeping 3 courts is a possibility. Adding a 4th is probably pie in the sky regardless of popularity or crowded conditions but as of now it seems it could still be on the table (probably close to the edge of the table, close to falling off).

We are allowed to attend a board meeting of course and express our views. However, (like Mick said) the board may not give any response or go into discussions at that time. We'd have limited time to speak (a few minutes) and the board most likely would not address each one of us individually but rather give a general response (if any) to the group after.

As I mentioned, the board is hearing us (and others). Ben said he'll speak with Carrie Fullerton next week because there is such a large number of responses/emails and see if they can't come up with some sort of

Maintenance expense for "more" courts is a big factor too but the total number of courts is the biggest factor. Apparently they take the NRPA's guidelines pretty seriously.
