### REQUEST:

Variation from Section 23-203a. of Chapter 23 of the Arlington Heights Municipal Code.

### BRIEF DESCRIPTION OF VARIANCE REQUEST:

With regards to Section 23-203a; This variance request is for the permission to construct a 100' monopole on a B-2 zoned property.

We are requesting a 100' tower because we build towers for co-location which helps eliminate the need for additional towers in the surrounding area for other carriers. This height will allow the co-location of two additional carriers thus eliminating additional towers in the area.

### SUBMITTAL REQUIREMENTS:

The following information must be provided with this application:

- \$110 Application Fee (Non-Refundable).
- 14 sets of drawings and all supporting documentation. All drawings must be folded into 11" by 17" and collated into sets.

The Building Code Review Board may recommend that variations be granted from provisions of the Building Code in cases where the applicant for such variation demonstrates practical difficulty and particular hardship. No variation may be granted without review and final action by the Village Board.

Now comes the Petitioner Peter Aimaro requesting a variation from Section 23-203a. of Chapter 23 of the Arlington Heights Municipal Code for the following reason:  
To install a wireless facility with a 100' monopole on a B-2 zoned property.

We are asking for an additional 25' above the maximum 75' in the village municipal code.

I hereby state that the following hardship would exist if the variance is not approved:

At 75' the proposed tower would accommodate less carriers for future co-location. At 100' the monopole is more marketable to future carriers, lessening the need for said future carriers to build new facilities.

At 100' feet we can get 2 additional carriers on the monopole.

I understand that any recommendation from the Building Code Review Board for a variation is subject to review and final action by the Village Board.
