# AN ORDINANCE DISSOLVING REDEVELOPMENT PROJECT AREA NO. 1 OF THE VILLAGE OF ARLINGTON HEIGHTS, ILLINOIS AND RELATED MATTERS

WHEREAS, pursuant to the Real Property Tax Increment Allocation Redevelopment Act, Division 74.4 of Article 11 of the Illinois Municipal Code, as amended (the "Act") and Ordinance Numbers 83-101, 83-102, 83-103, 83-121, 97-019 and 04-001, adopted on September 12, 1983, November 7, 1983, April 28, 1997 and January 20, 2004, as supplemented and amended, the Village of Arlington Heights, Illinois (the "Village"), adopted a redevelopment plan and a related redevelopment project (the "Redevelopment Plan" and "Redevelopment Project"), designated Redevelopment Project Area No. 1 (the "Redevelopment Project Area") (as described on the attachment to this Ordinance) and adopted tax increment finance for the Redevelopment Project Area;

WHEREAS, the Village Board has received the certification of the Village Treasurer and Director of Planning and Community Development that all redevelopment project costs for the Redevelopment Project Area have been paid, that all obligations in connection with the Redevelopment Project Area have been retired, and that all excess monies have been distributed; and

WHEREAS, notice of the dissolution of the special tax allocation fund and the dissolution of the Redevelopment Project Area was given by the Village on or before January 12, 2017 to all affected taxing districts,

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF ARLINGTON HEIGHTS:

SECTION ONE: The Village hereby dissolves the special tax allocation fund for the Redevelopment Project Area and dissolves the Redevelopment Project Area as a "Redevelopment Project Area" under the Act.

SECTION TWO: The Village Clerk shall immediately file a certified copy of this Ordinance with the County Clerk of Cook County, Illinois.

SECTION THREE: This Ordinance shall become effective immediately upon its passage and approval.

## VILLAGE OF ARLINGTON HEIGHTS REDEVELOPMENT AREA NO. 1

### **LEGAL DESCRIPTION**
