In accordance with your request Jameson Real Estate ("Jameson") has looked back over the marketing and prospect activity for the above referenced property. Following and enclosed is a summary report.

The property has been openly offered for sale since April 2006; perhaps earlier prior to Jameson's affiliation. Ownership took the property off the Multiple Listing Service from July 2008 to September 2013. Also, most of 2010 it was under contract with Daveri Development. However, Jameson has continuously maintained property information and availability in a number of subscription real estate databases favored by developers and their agents.

The land area is approximately 40,860 square feet or .94 acres. The asking price has been reduced twelve (12) times. Starting at \$959,000 or \$23.47 per square foot and dropping to \$299,000 or \$7.32 per square foot, a cumulative reduction of 69%.

During active marketing periods fifty-four (54) prospects inquired or were engaged by Jameson. The only offers received were submitted by Daveri Development and its successor, UP Development. Attempts to prompt offers at any price to start bargaining never succeeded.

Originally Jameson saw the site as a candidate for an owner/user building for office, medical office or destination retail uses. The extension of Boeger Drive to Old Arlington Heights Road made the site far less remote, but has yet to have a discernable impact on its marketability.

The attached report details prospect activity in several ways since 2007 including the identity of each inquirer.
