

**AN ORDINANCE DISSOLVING REDEVELOPMENT  
PROJECT AREA NO. 3 OF THE  
VILLAGE OF ARLINGTON HEIGHTS, ILLINOIS  
AND RELATED MATTERS**

WHEREAS, pursuant to the Real Property Tax Increment Allocation Redevelopment Act, Division 74.4 of Article 11 of the Illinois Municipal Code, as amended (the “Act”) and Ordinance Numbers 95-005, 95-006, and 95-007, adopted on January 17, 1995, as supplemented and amended, the Village of Arlington Heights, Illinois (the “Village”), adopted a redevelopment plan and a related redevelopment project (the “Redevelopment Plan” and “Redevelopment Project”), designated Redevelopment Project Area No. 3 (the “Redevelopment Project Area”) (as described on the attachment to this Ordinance) and adopted tax increment finance for the Redevelopment Project Area;

WHEREAS, the Village Board has received the certification of the Village Treasurer and Director of Planning and Community Development that all redevelopment project costs for the Redevelopment Project Area have been paid, that all obligations in connection with the Redevelopment Project Area have been retired, and that all excess monies have been distributed; and

WHEREAS, notice of the dissolution of the special tax allocation fund and the dissolution of the Redevelopment Project Area was given by the Village on or before October 12, 2017, to all affected taxing districts,

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF ARLINGTON HEIGHTS:

SECTION ONE: The Village hereby dissolves the special tax allocation fund for the Redevelopment Project Area and dissolves the Redevelopment Project Area as a “Redevelopment Project Area” under the Act.

SECTION TWO: The Village Clerk shall immediately file a certified copy of this Ordinance with the County Clerk of Cook County, Illinois.

SECTION THREE: This Ordinance shall become effective immediately upon its passage and approval.

**Legal Description**  
**Tax Increment Financing Area No. 3**

All that part of the West  $\frac{1}{2}$  of the Southwest  $\frac{1}{4}$  of Section 17, Township 42 North, Range 11 East of the Third Principal Meridian lying South of Rand Road described as follows:

Beginning at a point on the centerline of Rand Road that is 450 feet Northwesterly of the intersection of said line with the East line of the said West  $\frac{1}{2}$  of the Southwest  $\frac{1}{4}$  of Section 17, said intersection being 936.53 feet North of the South line of said section; thence Southeasterly 615.58 feet to a point in a line 775 feet North of and parallel with the South line of said section and 568.75 feet East of the West line of said West  $\frac{1}{2}$  of the Southwest  $\frac{1}{4}$  of said section; thence East along the North line of the South 775 feet of said section to the West line of the East 375 feet of the West  $\frac{1}{2}$  of the Southwest  $\frac{1}{4}$  aforesaid; thence South along said West line to the North line of the South 650.53 feet of said West  $\frac{1}{2}$  of the Southwest  $\frac{1}{4}$  ; thence East along said North line 375 feet to the East line of said West  $\frac{1}{2}$  of the Southwest  $\frac{1}{4}$ ; thence North along said East line to the point of beginning, excepting therefore all that part thereof taken for Rand Road and Arlington Heights Road, all in Cook County, Illinois.
