Mr. Recklaus said the Budget was presented over multiple Committee of the Whole meetings in November and on the website. It has been online since November 2, and at the Library and at Village Hall for viewing.

Keith Moens said this Public Hearing on the proposed Budget is just

minutes before its passing. It is too close to the vote to affect any change. The Hearing tonight is only to satisfy the State Statute and not really to get meaningful public input. Almost no questions were emailed to the website even though it encouraged proposing questions. The budget was presented and discussed at Committee of the Whole meetings, which are public, in November. No formal public comments were heard during those meetings. Then the 11/15 C.O.W. report was approved in Old Business. Even if you happened to catch that, it was really too late. He asked for C.O.W. meetings to have a Public Comments section in them in the future. This would allow residents to give their opinion from the very beginning of the discussion.

President Hayes said the public process was well stated by Mr. Moens. In the Village's defense, he said he does allow citizens to speak at C.O.W. meetings. President Hayes said he would do a better job to make sure he recognizes people in the audience and that Mr. Moens makes a good point. He said he would make sure that the Board factors in public input as they always have.

Jeb Weiner said he was moved by the women's march to get involved. He appreciated the Mayor's response to Mr. Moens. He said the Board should do all it can to encourage more public discourse. He said he would like the Village to address what can be done locally to address climate change and preventing gun violence. He said he hoped an open dialogue becomes the process.
